SUBJECT:

Cattle Hill Trail Improvements and Habitat Protection


As previously reported to the City Council, there is much deferred maintenance at Cattle Hill. Primary issues involve: 1) erosion from lack of trail maintenance, 2) the establishment of "social trails" which are causing additional erosion and habitat destruction, 3) lack of invasive plant species control, 4) ongoing motorcycle access, and 5) issues related to dog feces due to dog owners who do not pick up after their pets. While the long-term expectation has been that the National Park Service (NPS) would eventually take ownership of the parcel, it now appears very unlikely that will happen. Because of the expectation of NPS management of the property, the City has not taken steps to ensure the trails remain in good condition or that the habitat is protected from unwanted (social trails) or illegal access (motorcycles).


The OSPAC did organize a work day last fall to repair waterbars that had failed since constructed and create new ones as needed. While this improved erosion on the main trail, there are ongoing needs for erosion control on that trail. Additionally, the social trails need to be closed. OSPAC proposes to the City that it assist the Committee with taking some initial steps to close social trails, install signs (asking hikers and bikers to not cut trails as it causes habitat destruction and erosion), and make some minor modifications to the main trail to address access and erosion issues.


On May 16, 2016, the OSPAC submitted a modest proposal for approximately \$250 for stakes, cable, and signs to be placed in certain locations to block off social trails and inform trail users that they should remain on the trail. We have not heard from the City if this can be funded. Meanwhile, OSPAC members hiked the trail again from the end of Fassler Avenue to the Baquiano Trail (GGNRA) to be able to provide more specific locations for post and cable installation to cut off social trails and suggested locations for signage-cable barriers.



We believe there are longer-term needs at Cattle Hill that can be addressed by OSPAC attempting to obtain grant(s) (from the County or other sources) of sufficient size to hire professional contractors to reroute the main trail, install permanent barriers to the social trails, move soil and install erosion controls (coir blankets, coir erosion rolls, etc.) to fix the large gullies, and re-vegetate areas that have been damaged. OSPAC will commit to trying to find the funding to get this work accomplished. Dealing with the dog owners who do not pick up after their pets is another issue that will require additional signage, public outreach (via POOCH-coastside dogs and flyers to neighbors), and possibly the installation of a "Pet Pick Up" bag dispenser and waste bin at Fassler gate. http://www.coastsidedog.org/about-us/

SUBJECT: Ridge Trail Alignment Proposal on Pacifica Streets

Background:

The Bay Area Ridge Trail Council's mission is to create a continuous 550+/-mile trail for hikers, mountain bicyclists, and equestrians along the ridgelines overlooking San Francisco Bay. Today, over 365 miles of trail are dedicated and open to the public.

The Council works in close partnership with agencies and local government, parks, land trusts, and other stakeholders and volunteers to plan, acquire, design, build, care for, and promote the Ridge Trail.

The Ridge Trail is dedicated north thru Daly City all the way to northern Marin County, and from Sharp Park Road all the way south to Highway 92. We are about to open the new Milagra Ridge Trail above Connemara, funded in part by a Priority Conservation Area (PCA) Grant administered by the city (and based on the Ridge Trail's status as a region-wide PCA), and we are working with GGNRA to post appropriate Ridge Trail signage there. In addition, we have permission from Daly City for our volunteers to replace old faded signs there. Thus, the Pacifica streets section is the only gap in the area remaining to be closed.

Current status:

We propose to post Ridge Trail signs along the route from Daly City to Milagra Ridge.

- All work will be done by Ridge Trail volunteers.
- We will provide 10"x14" signs and directional arrows to mark the route.
- Wherever possible, signs will be posted in compliance with Pacifica sign guidelines.
- Where there is no existing signpost, light standard, or equivalent, we will propose simple post installation(s) to accomplish the wayfinding/route identification task.
- We anticipate completing all sign installations by mid-October.
