

RESOLUTION NO. 24-2020

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROPRIATING \$50,000 FROM THE CITY'S UNDESIGNATED GENERAL FUND BALANCE TO THE SAN MATEO COUNTY STRONG FUND TO ASSIST PACIFICA SMALL BUSINESSES.

WHEREAS, residents, businesses, and non-profits in the City of Pacifica and the County of San Mateo have been heavily impacted by the COVID-19 pandemic and the subsequent Shelter-In-Place Order; and

WHEREAS, on March 24, 2020 the San Mateo County Board of Supervisors approved \$3,000,000 in emergency funding to support those most impacted by the pandemic in partnership with the Silicon Valley Community Foundation; and

WHEREAS, the City has available \$50,000 of unassigned money in its Undesignated General Fund Balance that is available to provide relief to those that have been impacted by COVID-19; and

WHEREAS, on May 11, 2020 the City Council received a recommendation from the City Manager to consider appropriating \$50,000 to the San Mateo County Strong Fund to support small businesses in Pacifica.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Pacifica that \$50,000 is to be appropriated from the City's Undesignated General Fund Balance to the San Mateo County Strong Fund to assist Pacifica small businesses.
