

RESOLUTION NO. 36-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA AUTHORIZING THE CITY MANAGER TO EXECUTE AN AMENDMENT TO THE AGREEMENT WITH TURBO DATA SYSTEMS, INC. FOR CITY PARKING CITATION PROCESSING AND ADJUDICATION SERVICES

WHEREAS, a Countywide committee of involved local agencies issued a Request for Proposals for parking citation processing services in 2015; and

WHEREAS, Turbo Data Systems Inc. was selected to provide citation parking services to San Mateo County jurisdictions; and

WHEREAS, on August 10, 2015, the City Council Authorized the City Manager to execute an Agreement with Turbo Data Systems Inc. for the period July 1, 2015 until June 30, 2020 ("Agreement"); and

WHEREAS, the COVID-19 pandemic has reduced staffing levels in San Mateo County government agencies, necessitating the need for additional time to complete a Request for Proposal process for a new Agreement; and

WHEREAS, Turbo Data Systems Inc. and the City now desire to enter into an Amendment of the current Agreement, extending the term of the Agreement until June 30, 2021, to allow for the completion of a Request for Proposal process.

NOW, THEREFORE BE IT RESOLVED that the City Council of the City of Pacifica hereby approves and authorizes the execution of an amendment to the Agreement with Turbo Data Systems, Inc. for City Parking Citation Processing and Adjudication Services to extend the term of the Agreement until June 30, 2021 and authorizes the City Manager execute the Amendment to the Agreement with Turbo Data Systems, Inc. for and on behalf of the City of Pacifica, in a form approved by the City Attorney.
