RESOLUTION NO. 60-2020

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROVING A \$15 FEE FOR TEMPORARY RECREATIONAL VEHICLE LOADING/UNLOADING PERMITS AND A \$34 FEE FOR A DISC OF PHOTOS AND AMENDING THE CITY OF PACIFICA MASTER FEE AND CHARGES SCHEDULE, ATTACHED TO ADMINISTRATIVE POLICY NO. 2 TO ADD THOSE FEES

WHEREAS, Administrative Policy 2 sets forth procedures for the review and approval of City fees and charges; and

WHEREAS, on June 8, 2020, the City Council of the City of Pacifica passed and adopted a resolution amending Administrative Policy 2, amending the Master Fee and Charges Schedule set forth in Exhibit A attached thereto; and

WHEREAS, under the Police section of the fee schedule, the fee titled "Disc of Photos - \$34.00" was inadvertently omitted from the Master Fee and Charges Schedule presented to City Council; and

WHEREAS, on September 14, 2020, the City Council of the City of Pacifica adopted an ordinance amending Article 12 of Chapter 7, "Traffic" within Title 4 of the Pacifica Municipal Code relating to regulation of parking of Oversized Vehicles to add exemption relating to those Recreational Vehicles which display a temporary loading and unloading permit; and

WHEREAS, staff has determined that a fee of \$15.00 for a Temporary Recreational Vehicle Loading/Unloading Permit is needed to cover staff time and City costs incurred for processing and issuing a Temporary Recreational Vehicle Loading/Unloading Permit; and

WHEREAS, staff has determined that a fee of \$34 is need to cover staff time and City costs incurred in retrieving photographs and providing them on a compact disc.

NOW THEREFORE BE IT RESOLVED by the City Council of the City of Pacifica, California, that it hereby adopts the following fees and charges which reflect the reasonable costs of providing the service for which the fee is charged:

1. A \$34.00 fee for "Disc of Photos"; and

2. A \$15.00 fee for "Temporary Recreational Vehicle Loading/Unloading Permit."

BE IT FURTHER RESOLVED, that the City Council hereby amends the Police Department section within Exhibit A, "Master Fee and Charges Schedule," to Administrative Policy No. 2 to add the foregoing fees, as indicated in Attachment A, attached hereto.

BE IT FURTHER RESOLVED that any fees and charges that have been previously adopted by resolution and are not being modified in Attachment A, are incorporated in Attachment A for ease of reference only and without modifying or amending such fees or the underlying approvals in any manner.

CITY OF PACIFICA ADMINISTRATIVE POLICY	No. 2
CITY FEES AND CHARGES	DATE ISSUED: 9/81 Last Revised 6/22/20 Effective 7/1/20

PURPOSE:

The purpose of this policy is to establish procedures for the review and approval of City fees and charges.

POLICY:

- 1. It shall be the policy of the City to establish fees and charges for City services which fully reimburse the City for the associated services, unless specified otherwise by the City Council. City fees and charges shall not be assessed to other governmental agencies or the press.
- 2. All fees and charges shall be reviewed and updated annually in conjunction with the review of the City's budget to insure that they are adequate and to relate them to their associated program cost.
- 3. All City fees and charges shall be included in Exhibit A of this Administrative Policy and not included in City ordinances or other policies to facilitate their review and updating.

PROCEDURE:

- 1. Each year in conjunction with the City budget process, Finance shall request City departments to review their fees and charges and propose any modifications.
- 2. Upon receipt of the proposed modifications to the fees and charges, Finance shall review them to insure that they comply with the City's policy for full reimbursement of associated City service costs.
- 3. Upon completion of this review, the proposed new fees and charges shall be forwarded by Finance to the City Manager for final review and approval prior to being submitted to the city Council.
- 4. After review and approval by the City Manager, the new fees and charges shall be included in the proposed City budget for final City Council review and approval.

- 5. The proposed fees and charges shall be used to determine the estimated revenue for all City programs and shall be set forth in the budget with the associated program expenditure estimates.
- 6. The public hearing on the proposed fees and charges shall be consolidated with the City's public hearing on its budget.
- 7. All changes to City fees and charges should be considered at one time during the budget review rather than a different time during the year.
