Argument Against Measure __

Now is not the time to take away hundreds of thousands of dollars in annual income from Pacifica's youth sports, schools, veterans, and community nonprofit groups!

VOTE NO ON MEASURE ___!

Over the last 20 years, Pacifica's nonprofit community groups have raised over \$3.2 million selling California State Fire Marshal-Approved Safe and Sane Fireworks each 4th of July. These funds have been reinvested in Pacifica's high school sports teams, youth soccer and baseball teams, food banks, military care packages, scholarships, help for moderate and low income families, and maintenance and improvements on community sports fields.

Measure __ is the wrong answer for Pacifica!

State-Approved Fireworks sold by the Pacifica nonprofit organizations are not the problem in Pacifica. Illegal fireworks are the problem! Both fire and police have consistently maintained that State-Approved Fireworks have not been a serious problem.

Banning the use of State-Approved Fireworks will not lead to less illegal fireworks, it will lead to more illegal fireworks!

Measure __ will not stop the use of dangerous, illegal fireworks – like M-80s, firecrackers and aerial shells. Communities that have banned State-Approved Fireworks have seen as much as a 300% increase in the use of illegal fireworks! Measure __ puts Pacifica at serious risk!

In addition to the nonprofits losing \$200,000 in annual revenue to fund the critical programs they provide, banning State-Approved Fireworks will result in the City of Pacifica losing over \$45,000 each year that the nonprofits give to the City to fund the City's illegal fireworks enforcement program.
