Sarah,

Would you please mention to the council members that I would like to add the following to the tree preservation?

- 1. Need to separate out the invasive trees for eventual replacement vs. native trees for protection.
- 2. Input in the tree preservation document to phase out invasive trees with native trees, even if the invasive trees are in a grove.
- 3. Undesirable tree definition: Hazardous to people, buildings, and/or other infrastructures; prone to fire hazardous due to trees with high oil content such as eucalyptus, invasive roots causing underground utility damages; interference with road signages, vehicle travel, and/or prone to falling; and other factors that are harmful to the surrounding.
- 4. Encourage planting of more native trees and plants to reduce our drought condition.
- 5. Need to review tree planting and/or replacement through the urban landscaping point of view, don't just plant trees without a good landscaping plan.
