

RESOLUTION NO. 63-2022

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA
AUTHORIZING THE CITY MANAGER TO EXECUTE A FIRST AMENDMENT TO
THE CONSULTANT SERVICES AGREEMENT WITH DYETT & BHATIA URBAN
AND REGIONAL PLANNERS FOR PROFESSIONAL PLANNING AND RELATED
SERVICES.**

WHEREAS, consistent with the City of Pacifica's Purchasing Policy (Administrative Policy No. 76), the City of Pacifica entered into an agreement with Dyett & Bhatia Urban and Regional Planners ("Dyett & Bhatia") for consulting services under the City Council's purchasing authority in January 2019; and

WHEREAS, the level of effort required to finalize the General Plan update, creation of a new Sharp Park Specific Plan, and California Environmental Quality Act review of these items exceeded the estimates used to establish the original agreement amount; and

WHEREAS, the City Council of the City of Pacifica has considered the City Manager's recommendation to approve a first amendment to the City's agreement with Dyett & Bhatia for consulting services on September 26, 2022.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Pacifica to authorize the City Manager to amend the agreement with Dyett & Bhatia for the purpose of increasing the cost ceiling to an amount not to exceed \$792,000 and extending the term of the contract through June 30, 2023.
