City of Pacifica Emergency Health and Safety Ordinance enacting project called: "Protection city of Pacifica residents from transmitting illegal forced and unwanted microwave, radio, audio, ultrasound, infrared or any other form of energy."

Average person don't have any means to stop transmittions and/or remove implants. Exclusion: Illegal public gatherings-protests, demonstrations, riots, coups when law enforcement personnel may use legal tools: microwave crowd dispensers, acoustic devices, radio jammers and more means beyond scope of this ordinance.

This ordinance is in compliance with the State of California laws: 646.9, 422, 647i, 632, 631.

This ordinance is in compliance with the Sate of United States laws: Title III Of 1968, 18USC Charter 119, 18USC Chapter 1801, 18USC Paragraph 871, 18USC Paragraph 2261. We at VVO need help of City Attorney to make this ordinance more closely compliant to state and federal laws.
