

**RESOLUTION NO. 52-2023**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA TO AMEND THE FY 2022-23 BUDGET TO INCLUDE ADDITIONAL APPROPRIATION AND EXPENSE FROM THE DISASTER ACCOUNTING FUND IN THE AMOUNT OF \$1,923,500**

**WHEREAS**, the City Council adopted the FY 2022-23 Operating and Capital Budget on June 27, 2022; and

**WHEREAS**, the City filed a complaint in eminent domain to condemn portion of property located at 310 and 320 Esplanade Avenue (APN 009-413-010 and 009-413-020) for the 310-330 Esplanade Infrastructure Preservation Project; and

**WHEREAS**, the City deposited an appraised property's fair market value of \$76,500 into the State of California Condemnation Fund as a deposit of probable just compensation; and

**WHEREAS**, on May 22, 2023, Judge Weiner issued an order requiring the City to increase the deposit from \$76,500 to \$2 million within thirty days; and

**NOW, THEREFORE, THE PACIFICA CITY COUNCIL RESOLVES AS FOLLOWS:**

The FY 2022-23 Budget to be amended to include an additional appropriation of \$1,923,500 from the available fund balance of the Disaster Accounting Fund (Fund 38) and deposit these funds in the State of California Condemnation Fund.
