My neighbors and friends know who I am. The people I help know who I am. It is time to bring more good honest people into these Pacifica committees. I will help bring the moral compass back from hate. If you dont pick me it is clear that Pacifica's political agenda is more important than doing what is best for the city of Pacifica's residents, trails, and largest base of trail users.

Without me the trails would be in shambles and would still be a huge liability for our city. I am fixing these trails and making bridges to connect mountain bikers with hikers and other trail users. I am trying to do things the right way. I am the light that will bring balance to the hate. I am the only choice.
