

RESOLUTION NO. 31-2024

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF PACIFICA APPROVING THE CONSTRUCTION CONTRACT BETWEEN THE CITY OF PACIFICA AND RK ENGINEERING INC. FOR THE FY 2024-25 SIDEWALK, CURBS, AND ADA RAMPS IMPROVEMENT PROJECT IN AN AMOUNT NOT TO EXCEED \$157,939.00; AUTHORIZE A BUDGET AUTHORITY IN THE AMOUNT OF \$205,320.70, WHICH INCLUDES CONTINGENCIES IN AN AMOUNT NOT TO EXCEED THIRTY PERCENT (30%) OF THE CONSTRUCTION CONTRACT AMOUNTS; AUTHORIZE STAFF TO EXECUTE FUTURE CHANGE ORDERS AND TASK ORDERS NOT TO EXCEED THE CONTINGENCY AMOUNT; AND AUTHORIZE THE CITY MANAGER TO SIGN CONTRACT DOCUMENTS RELATED TO THE PROJECT

**WHEREAS**, consistent with the City of Pacifica's Bidding Procedures for Public Projects (Municipal Code Title 3 Chapter 15) the City of Pacifica advertised the Request for Bids for FY 2024-25 Sidewalk, Curbs, and ADA Ramps Improvement Project on February 21, 2024, and February 28, 2024; and

**WHEREAS**, the low bidder was RK Engineering, Inc.;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City Pacifica Adopt the Resolution Approving the Construction Contract between the City of Pacifica and RK Engineering Inc. for the FY 2024-25 Sidewalk, Curbs, and ADA Ramps Improvement Project in an amount not to exceed \$157,939.00; Authorize a budget authority in the amount of \$205,320.70, which includes contingencies in an amount not to exceed thirty percent (30%) of the Construction Contract amounts; Authorize staff to Execute Future Change Orders and Task Orders not to exceed the contingency amount; and Authorize the City Manager to sign Contract Documents related to the Project.




