Hello Mr. Woodhouse,

I wasn't sure where to address this, given there is usually a separate ethics body within municipalities. Please let me know if this should be addressed to someone else within the City of Pacifica, or something that needs to be dealt with at the State level.

I noticed an agenda item on today's calendar about "Campaign Contribution Limits and Reporting and Disclosure Regulations in Local Elections", a topic rooted in political ethics and conflict of interest. There have been numerous conversations online about a biased City Council - specifically a council vested in real estate interests.

Given the item on today's agenda, I was wondering how often city elected officials and staff get training and refreshers on the relevant laws and recusal process. In my years as a civil servant with the City and County of San Francisco, training took place annually, so did any compliance requirements related to the Fair Political Practices Act/Laws. Specifically, I declared any conflicts, potential conflicts and was not involved in processes should conflict be an issue.

I've shared some resources(links below), the video is specific to the state of California and clearly within the first minute and half covers the concerns Pacificans have about City Council. Given the number of real estate related issues currently on hand, it seems prudent to discuss conflict of interest with staff and council members and the process to recuse themselves.
