As noted by at least one other person, West Sharp Park is in a tsunami zone and will be inundated by sea level rise due to anthropomorphic climate change, and it's coming sooner than most people seem to think.

West Sharp Park has been touted as Pacifica's "downtown" by city officials since at least the 1960's, when my late mother ran a business there at that time. It wasn't true then, and it's not true now. The bifurcation of the city by the Hwy. 1 freeway/trench precluded that from happening in the 1960's as well. A new streetscape, although pleasant, has not brought a slew of new businesses to Sharp Park either.

I would oppose the city's putting scarce financial resources toward this fantasy of a project.

Please add the following to the record for the Sharp Park Specific Plan Guiding Policy Framework Discussion that is on the City Council agenda on Monday, July 20<sup>th</sup>. The comments reiterate concerns and comments raised by Commission staff during a phone call with Commission and City staff on April 3, 2020.

As the Sharp Park Specific Plan proposes to increase height and density allowances within the Sharp Park neighborhood, a thorough analysis should be conducted in terms of visual impacts of development as provided through the Specific Plan on the character of the surrounding area and on views through the neighborhoods of the ocean, impacts to community character as designated and provided in the LCLUP, and impacts of potential geotechnical and coastal hazards on development that per the current proposal would be of increased height and density than currently allowed. Any allowed uses in the Specific Plan should prioritize low-cost visitor-serving, recreational uses and public access. In addition, the Specific Plan would need to provide for increased coastal resource protections in order to ensure consistency with the Coastal Act, and documentation should be provided including visual simulations, height and density alternatives, explanations of the hazards within this particular neighborhood, and the benefit to the public with regard to priority uses in this coastal area. More specifically, the City should consider:

- Reducing the proposed height in areas in which tall buildings (up to 55 feet in height) will impact the visual
  character of surrounding areas as well as public views to and from the ocean in visually sensitive areas, and
- Performing a thorough geotechnical analysis, including an evaluation of the potential hazards to this
  neighborhood (landslides and shoreline erosion) as well as a wave uprush study for the area. Such a wave
  uprush study should include an assessment of the potential hazards caused by 100-year storm events
  (cumulative with high tide events, as well as projected sea level rise impacts and given a typical eroded beach
  condition).

We look forward to continuing to work with the City on this Specific Plan throughout the City's drafting and review process. Thank you.

**Message:** The visualizations are nice especially with the trees, but I have not seen that the actual plan has infrastructure to support trees. Trees are vital to all humans (and all other oxygen breathers) on Earth. Trees help greatly in many ways. To name a few.

A mature tree can absorb approximately 150 kg of CO2 per year.

Research suggests a 60% reduction in particulates from car exhaust as well as reducing ozone, dust, dirt, and smoke

Trees increase property value and rents between 3 and 20 percent

Trees provide runoff control and preserve hills from mudslides and erosion

Trees block noise as much as 40%

Shoppers claim to spend 9 to 12% more for goods and services in areas with a high quality tree canopy

Trees help build community and create a sense of space, reportedly fostering better relationships with neighbors and even lowering incidents of domestic violence.

Please please incorporate trees into the actual design drawings, plans, and requirements. And owners to maintain them in some way.

i realize that palmetto ave is considered 'main street' pacifica, but - we are not half moon bay. we don't have the businesses, there's a large percentage of apartments and homes on the street already, and i don't believe those of us who live here want the traffic, parking issues, and crowds of people. i've lived in this building for 20 years, and have welcomed the new businesses along palmetto. and i do realize as well that pacifica needs to attract income. i believe the city does have other options, and other open spaces that can be developed; i don't see why the council has to, in it's zeal for attracting business, wreck my neighborhood, there are vacant spaces in a lot the shopping centers - eureka square, linda mar - if businesses want to move in.

do any of the council members actually live on or near palmetto? what is their input? will they welcome people marching up and down their streets, parking in and blocking their driveways? do they welcome the noise level that's going to increase, especially if you have after hours businesses? we can't keep the beaches and parking lots clean - how are you going to fix the trash issue that's going to spring up?

this is a quiet neighborhood, and i believe those of us who live here like it that way. please don't ruin the community and neighborliness we have going on already
