<b>San Diego</b>	<ul style="list-style-type: none"> <li>Overnight camps-No more than 14 students in the water, 28 students max.</li> <li>Private/Semi Private Surf Lessons - 9 students max.</li> <li>No instruction weekends or holidays Memorial Day -Labor Day annually.</li> <li>Private/Semi-private lessons must have no more than 3 students per instructor and 9 students per class maximum.</li> <li>Adhere to the requirements for student to instructor ratios (3 students maximum per instructor)</li> </ul>	Pacific Beach is approximatley 1,200 feet/ 400 yards in length.

City may issue a maximum of four</li> <li>The total number of surf school students during any single period of time in the water at the Cowell Beach Recreation Area shall not exceed 32 students.</li> </ul>	Cowell's Beach length is approximately 1,600 feet/ 530 yards long.	
<b>Santa Monica</b>	<ul style="list-style-type: none"> <li>Maximum student/instructor ratio in the water is 5 to 1.</li> <li>Maximum student/instructor ratio on the sand is 10 to 1.</li> <li>Maximum number of students on the sand at one time is 60.</li> <li>Maximum number of students in the water at one time is 25.</li> </ul>	There is approximatley 600 ft/250 yards length between Towers 27 and 28. Lifeguard towers 27 & 28 are approximatley 900 ft/ 300 yars away from one another. Lifeguard tower is 6 is approximatley 2000 ft/ 667 yards long.
