NOTICE OF HEARING ON PROPOSED PUBLIC ART (MURAL)

NOTICE IS HEREBY GIVEN that the Beautification Advisory Committee (BAC) of the City of Pacifica will conduct a public hearing at 7:00 p.m. on Wednesday, August 7, 2019 in the Community Center, Card Room, 540 Crespi Drive to consider the following:

The installation of a mural on the west side of the Community Center building. The mural will commemorate the 250th Anniversary of the Portola-Ohlone Expedition. The artist selected for the project is Jeffrey Wong who will be present at the hearing to answer any questions or concerns from the public.

Anyone interested may appear and be heard at the time and place noted above. Members of the public will have three minutes to address the BAC. At the public hearing, the Beautification Advisory Committee will consider all public input and will vote on whether to proceed with the project.

Any person(s) aggrieved by any decision of the BAC may appeal that decision to the City Council, in writing, within ten (10) calendar days for a fee of \$500.00. Upon appeal, the City Council may approve, deny, or modify the decision of the BAC or refer the matter back to the BAC for reconsideration.

The City of Pacifica will provide special assistance for persons with disabilities upon at least 24 hours advance notice to the Community Center's office at (650) 738-7378. If you need sign language assistance or written material printed in a larger font or taped, advance notice is necessary. All meeting rooms are accessible to persons with disabilities.
